Our Organisation and Business

Partners Group is one of the largest firms in the global private markets industry, with 1'800 professionals and approximately USD 152 billion in assets under management. The firm has investment programs and custom mandates spanning private equity, private credit, infrastructure, real estate, and royalties. With its heritage in Switzerland and its primary presence in the Americas in Colorado, Partners Group is built differently from the rest of the industry. The firm leverages its differentiated culture and its operationally oriented approach to identify attractive investment themes and to build businesses and assets into market leaders

We, Partners Group (UK) Ltd. ("Partners Group UK"), are a subsidiary of Partners Group with an office in London and are the alternative investment fund manager of the Partners Group Generations Fund domiciled in the UK.

As demonstrated in Partners Group's Global Sustainability Directive, Exclusion Policy (Opt-in) and Code of Conduct, we are committed to high ethical standards and to responsible investments and sustainable business practices. We believe that it is our corporate responsibility to create substantial value from environmental, social and governance (ESG) factors throughout our investment portfolios. The Modern Slavery Act was enacted by the UK Government in 2015 to tackle all forms of modern slavery, including forced, compulsory or coerced labour, and human trafficking. Partners Group UK provides this Modern Slavery Statement pursuant to section 54 of the Act. This statement does not discuss the compliance activities of investments in which the fund managed by Partners Group UK have invested, none of which are subsidiaries of Partners Group UK.

Our Services, Employees and Supply Chain

As a large employer and asset manager, we recognize the legal, ethical, and societal significance of upholding human rights along the value chain. At Partners Group, we consider three key pillars in our own operations and supply chain: human rights, working conditions, and health and safety. We are not only committed to high ethical standards and sustainable business practices in relation to responsible investments and own operations but are also committed to leading our firm in a principled manner.

The quality of our services is driven by our employees. Our employees are our most important asset and the key to our success.

Our suppliers are our partners, reflecting our core values in their business operations, and we expect them to uphold exemplary business conduct, integrity, and legal compliance.

We aim to engage with reputable providers of professional and advisory services. Other material suppliers to our UK office in London include providers of office equipment, and of administrative, secretarial, cleaning, and catering services.

Our Slavery and Human Trafficking Risks

In our regulated investment management business, the risk of modern slavery and human trafficking, by definition, continues to be very low. We can only hire employees fulfilling our rigorous criteria (e.g. age, experience), with appropriate skills, training and without a criminal record. Therefore, we are competing with other service providers to attract the best professionals and provide them with a demanding and rewarding working environment.

Based on our continued assessment of risk factors such as the location and nature of services provided and potential for exploitation of the related workforce, the risk of modern slavery and human trafficking in our supply chain also continues to be very limited because our service providers are primarily providers of professional and advisory services.

Nonetheless, in appropriate cases (e.g. a type of service is assessed as potentially posing greater risk) we may require certain providers to complete modern slavery risk assessments and include modern slavery clauses in their contracts.

Our Slavery and Human Trafficking Prevention Endeavours

We endeavour to prevent slavery and human trafficking in our business and supply chains by:

- our various policies and procedures that reflect our endeavours and raised awareness in relation to the prevention of modern slavery and human trafficking, including for example our Anti-Money Laundering Policies and Directives, Code of Conduct, Supplier Code of Conduct, and Speak-up Directive which require our staff to report any misconduct or breach of our policies, and illegal behaviour, including violations of human rights.
- maintaining a register of reports of actual or suspected incidents of modern slavery in our business or supply chain.
- periodically reviewing and adapting our company policies and procedures to raise awareness and further develop endeavours in the prevention of modern slavery and subjecting our procedures to periodic internal checks as well as local laws and regulations.
- subjecting new prospective employees to strict checks on their identity, references, qualifications and criminal records without exception.
- training, such as mandatory onboarding and annual compliance training on our related policies and procedures provided generally to staff, and as needed providing more detailed guidance and materials to specific members of staff and management, as to the nature, risks, signs, and prevention of modern slavery.
- obtaining services from reputable service providers who are subject to our overall supplier and service procurement suitability assessments and processes; and
- requiring certain service providers in appropriate cases to complete a modern slavery risk assessment questionnaire and agree to modern slavery clauses in their contract and creating and maintaining templates for this purpose.
- ensuring compliance with our Supplier Code of Conduct by engaging with suppliers who share our ethical commitments and values. This code outlines our expectations by setting minimum standards for ethical behaviour, compliance with labour and human rights regulations, and adherence to environmental, health, and safety responsibilities.

We continue to keep our relevant policies and processes and their implementation under active review, to be alert to the risks of slavery and human trafficking in our own business or in our supply chains and remain ready to identify potential gaps or areas of improvement and take appropriate action promptly to address any concerns that may arise.

The ongoing effectiveness of endeavours in relation to the prevention of modern slavery and human trafficking can be assessed over time by indicators such as not receiving any reports indicating modern slavery practices have been identified, tracking of when employees complete relevant training, and our employees' continued adherence to our applicable policies or procedures.

This Statement

This statement is made pursuant to section 54(1) of the Modern Slavery Act 2015 and was approved by the Board of Directors of Partners Group UK on 27 June 2025. It constitutes our modern slavery and human trafficking statement for the business year 2024.
